IF THIS HAPPENS	DO THIS
<b>TANKER/VEHICLE ACCIDENT</b>	Switch off engine and electrical equipment. Keep people away. Warn other traffic. Check for spills and leaks. <b>Call the emergency services: Dial 111</b>
<b>SPILL OR LEAK</b>	Caution: Floors may be slippery if wet. Wear waterproof overalls, gloves, boots and safety glasses/goggles. Keep bystanders away. Prevent further spillage or leakage. Prevent material from entering drains, waterways, etc. Absorb spillage with inert material such as spill kit, sand or cat litter. Collect and place in a sealable container for disposal. Wash down affected area with water and detergent. Absorb and collect washings for disposal. Dispose of safely to a suitable landfill.
<b>FIRE</b>	<b>Call the Fire Service: Dial 111.</b> Wear protective clothing including self-contained breathing apparatus. Toxic fumes may be released. Keep people away. Extinguish fires with dry chemical, CO <sub>2</sub> , water spray or foam. Cool other containers to prevent rupture. Contain run-off.

<b>IF SWALLOWED</b>	Seek medical advice if feeling unwell.

<b>IF ON SKIN</b>	Wash with plenty of soap and water. Seek medical advice if irritation occurs.
