**HANDLING REQUIREMENTS**

**PERSONAL PROTECTION**

**STORAGE**

**GENERAL INFORMATION**

TERMINATOR G4 is a non-selective herbicide for the control of a wide range of annual and perennial grasses and broadleaf weeds. Terminator G4 provides rapid knockdown and residual control of weeds through both foliar and root uptake. Terminator G4 is suitable for use around buildings, yards, fence lines, driveways, etc., and other areas where total vegetation control is required.

**DIRECTIONS FOR USE****RATES OF APPLICATION**

**Broadcast:** 20 – 25 litres per hectare at a suitable water rate to achieve good weed coverage

**Brushgun:** 2 litres per 100 litres

**Knapsack:** 25 mL per litre

The maximum application rate is 25 L/ha (1.5 kg amitrrole, 2.5 kg glyphosate, 0.375 kg oxyfluorfen and 8.75 kg terbutylazine /ha) with a maximum of two applications per year.

**MIXING**

Fill the clean spray tank with half the required amount of clean water. Add TERMINATOR G4 as required and mix well before adding the remaining water. Maintain agitation throughout spraying.

TERMINATOR G4 is compatible with most commonly used herbicides.
