## READ THE LABEL BEFORE USE

### PRECAUTIONS

Apply with well maintained and calibrated spray equipment.

### DISPOSAL

Dispose of this product by using it in accordance with this label. Dispose of the container via AgRecovery after triple rinsing (use the rinsate for spraying). Do not burn. Do not use the container for any other purpose.

### ENVIRONMENTAL

Take all reasonable steps to ensure that this product does not cause any significant adverse effects to the environment beyond the application area. Do not apply directly into or onto water. In the event of spillage, exclude non-essential people from the area. Wear protective equipment and prevent from entering drains. Contain and collect spillage for disposal.

### GENERAL INFORMATION

Synergy Wetter Sticker will improve wetting and sticking characteristics of herbicides, fungicides and insecticides, especially in marginal conditions where plants are hairy, waxy, dusty or weather hardened. Synergy Wetter Sticker can also be used as a soil active wetting agent to improve the performance of soil applied insecticides.

**WARNING:** This product should be used with caution as it can increase the risk of crop damage. Carefully check the primary product label for compatibility and directions for use. Any directions given on the primary product label will take precedence over directions given on this label. Check carefully for permissibility of use where export spray programmes are being followed.

**Active Ingredient:** 780 g/L alkyl phenol ethoxylate. Also contains 18% 2-(2-butoxyethoxy)ethanol

Add product to the partially filled spray tank after the addition of the primary product. Maintain agitation through filling and spraying.
