### EMERGENCY PROCEDURES

IF THIS HAPPENS	DO THIS
<b>TANKER/VEHICLE ACCIDENT</b>	Switch off engine and electrical equipment. Keep people away. Warn other traffic. Check for spills and leaks. <b>Call the emergency services: Dial 111</b>
<b>SPILL OR LEAK</b>	Caution: Floors may be slippery if wet. Wear chemical resistant coveralls with hood tightly fitting at head, wrists and ankles (e.g., Tychem F suit), chemical resistant boots and chemical resistant gloves (e.g., barrier multilayer, nitrile) and safety glasses/goggles. Keep bystanders away. Prevent further spillage or leakage. Prevent material from entering drains, waterways, etc. Absorb spillage with inert material such as spill kit, sand or cat litter. Collect and place in a sealable container for disposal. Wash down affected area with water and detergent. Absorb and collect washings for disposal. Dispose of safely to a suitable landfill.
<b>FIRE</b>	<b>Call the Fire Service: Dial 111.</b> Wear protective clothing including self-contained breathing apparatus. Toxic fumes may be released. Keep people away. Extinguish fires with dry chemical, CO <sub>2</sub> , water spray or foam. Cool other containers to prevent rupture. Contain run-off.

### FIRST AID

<b>IF SWALLOWED</b>	Rinse mouth. Get medical help. Call the National Poisons Centre 0800 764 766 or a Doctor.
<b>IF IN EYES</b>	Rinse cautiously with water for several minutes. Remove contact lenses, if easy to do so. Continue rinsing. Seek medical advice if irritation persists. Call the National Poisons Centre 0800 764 766 or a Doctor.
<b>IF ON SKIN</b>	Wash with plenty of soap and water. Get medical help. Call the National Poisons Centre 0800 764 766 or a Doctor.
<b>IF INHALED</b>	Remove to fresh air and keep at rest in a position comfortable for breathing. Get medical help. Call the National Poisons Centre 0800 764 766 or a Doctor.

### STORAGE AND SEGREGATION SUMMARY

**Storage:** Keep out of reach of children. Store in the original tightly closed container in a secure area.
