

This product must only be handled, mixed and applied by a suitably qualified person, as define under the HPC notice 2017 Part 4C. Records of use as described in NZS 8409 Management of Agrichemicals must be kept if 3 L or more is applied within 24 hours and likely to leave the application area.

PERSONAL PROTECTION

Avoid contact with eyes and skin. Do not breathe in the vapour or spray mist. When mixing or applying, wear chemical resistant overalls, boots, gloves, and eye protection. Wear a respirator if vapour or spray mist could be inhaled. Do not eat, drink or smoke during use. Clean protective equipment after use. Do not take contaminated equipment or clothing off site. Wash contaminated clothing before reuse. Wash hands after use.

STORAGE

Keep out of reach of children. Store in the original container in a cool, well ventilated and secure area. When stored appropriately this product should show no significant degradation for two years from the date of manufacture. Contact your supplier for further information about the use of product that is older than this.

DISPOSAL

Dispose of this product by using it in accordance with this label. Dispose of the container via AgRecovery after triple rinsing (use the rinsate for spraying). Do not burn. Do not use the container for any other purpose.

ENVIRONMENTAL

Take all reasonable steps to ensure that this product does not cause any significant adverse effects to the environment beyond the application area. This product must be applied using ground-based methods only. Do not apply directly into or onto water. In the event of spillage, exclude non-essential people from the area. Wear protective equipment and prevent from entering drains. Contain and collect spillage for disposal.

FIRST AID

If swallowed: Rinse mouth. Seek medical advice.

GENERAL INFORMATION

Guvnor Gold contains 960 g/L of S-metolachlor as the active ingredient; and up to 10% w/v of benoxacor as a safener. Guvnor Gold is a herbicide for the selective pre-emergence control of annual grasses in maize, sweetcorn, asparagus (established), pumpkins and squash.

Weeds controlled: Commonly occurring annual grass weeds including summer grass, barnyard grass, bristle grasses, witch grasses and crowfoot grass.

Guvnor Gold contains s-metolachlor, which belongs to the chloroacetamides chemical family. Resistance to this and other chloroacetamide or oxyacetamide herbicides could develop from excessive use. To minimise this risk, use strictly in accordance with label instructions and rotate use with herbicides with a different mode of action. DIRECTIONS FOR USE

Apply with well-maintained and calibrated spray equipment.

| Maize, Sweetcorn | Barnyard Grass, Bristle Grasses, Crowfoot Grass, Summer Grass, Witch Grasses | 5 L | Apply to a freshly prepared seedbed immediately after planting and before crop emergence. Do NOT apply after crop emergence, as scorching can occur, and the control of grasses is less effective. Effectiveness is greatly reduced on peat soils. For the control of annual broadleaf weeds, use other products such as Atrflow™ (other than for fathen resistant to triazine herbicides), Dominator® or Orion Nico Ultra, applied as a post emergence spray according to label directions. |
| Pumpkins, Squash | | 1 L | Apply to a freshly prepared seedbed immediately after planting and before crop emergence. Do NOT exceed the recommended rate of application as crop damage may occur |

It is an offence for users of this product to cause residues exceeding the relevant MRL in the Food Notice: Maximum Residue Levels for Agricultural Compounds.

Note: Maximum application rate is 4.8 kg s-metolachlor/ha. Do not exceed the application rates specified.

APPLICATION METHODS

Ground Application: Apply in a minimum of 200 L / ha of water.

MIXING

Partly fill the spray tank with water, and add the required quantity of Guvnor Gold. Maintain agitation through filling and spraying.

COMPATIBILITY

Compatible with most commonly used herbicides in maize and asparagus.

SOIL CONDITIONS/RAINFALL

Best results will be obtained when application is made to a freshly prepared, fine, moist soil, free of trash, with at least 10 mm of rain within 1 week of application. Under drier soil conditions, 30 mm or more of rain within 2 – 3 weeks is necessary.

SOIL RESIDUES

To minimise soil residues, areas treated with Guvnor Gold should be deeply cross-cultivated to ensure maximum dispersal of residues. Certain susceptible crops such as ryegrass and some small grain cereals should not be sown in areas which have been treated with Guvnor Gold in the previous 5 months, without first obtaining advice from your local Orion AgriScience representative.
