READ LABEL BEFORE USE

STORAGE

USE

Apply with well maintained and calibrated spray equipment.

Dispose of this product by using it in accordance with this label. Dispose of the container via AgRecovery after triple rinsing (use the rinsate for spraying). Do not burn. Do not use the container for any other purpose.

GENERAL INFORMATION

Gnarly is an adjuvant specifically for use with Brush Off® and Mustang® herbicides for wilding pine control. Gnarly enhances coverage and penetration to increase the effectiveness of herbicide control.

INGREDIENTS

Gnarly contains an organosilicone / alcohol ethoxylate / methylated seed oil blend.

APPLICATION RATES

Knapsack: Use 150 mL per 10 L of spray mix

Aerial: Use 4 L per ha. A water rate of 400 L/ha is recommended.

MIXING

Partly fill the spray tank with water, and add the required quantity of partner herbicide products. Add Gnarly last to minimise foaming. Maintain agitation through filling and spraying.

COMPATIBILITY

Compatible with most commonly used herbicides for wilding pine control.

WARRANTY

This formulation is warranted to contain the specified ingredients within accepted analytical tolerance when packed.
