### EMERGENCY PROCEDURES

24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 243 622

IF THIS HAPPENS	DO THIS
<b>TANKER/VEHICLE ACCIDENT</b>	Switch off engine and electrical equipment. Keep people away. Warn other traffic. Check for spills and leaks. <b>Call the emergency services: Dial 111</b>
<b>SPILL OR LEAK</b>	Keep bystanders away. Wear overalls, waterproof gloves, boots and safety glasses/goggles. Prevent further spillage. Moisten to prevent dusting and carefully sweep up. Do not inhale dust. If dust is generated, wear respiratory protection. Place spilled product in a sealable container. Wash affected area with water detergent solution. Absorb washings and place in a sealed container. Dispose of to a suitable landfill
<b>FIRE</b>	<b>Call the Fire Service: Dial 111.</b> Wear protective clothing including self-contained breathing apparatus. Toxic fumes may be released. Keep people away. Extinguish fires with dry chemical, CO <sub>2</sub> , water spray or foam. Avoid water jet. Cool other containers to prevent rupture. Contain run-off.

### FIRST AID

<b>IF SWALLOWED</b>	Seek medical advice if feeling unwell. Call the National Poisons Centre 0800 764 766 or a Doctor.
<b>IF IN EYES</b>	Rinse cautiously with water for several minutes. Remove contact lenses, if easy to do so. Continue rinsing. Seek medical advice if irritation persists. Call the National Poisons Centre 0800 764 766 or a Doctor.
<b>IF ON SKIN</b>	Wash with plenty of soap and water. Seek medical advice if irritation occurs. Call the National Poisons Centre 0800 764 766 or a Doctor.
<b>IF INHALED</b>	Remove to fresh air and keep at rest in a position comfortable for breathing. Seek medical advice if feeling unwell. Call the National Poisons Centre 0800 764 766 or a Doctor.

### STORAGE AND SEGREGATION SUMMARY

**Storage:** Keep out of reach of children. Store in the original tightly closed container in a secure area.

**Aggregate Storage Volume Thresholds:** When stored with other hazardous substances, the aggregate quantity must be considered. For full details, refer to Health and Safety at Work (Hazardous Substances) Regs 2017, and Hazardous Substances (Hazardous Property Controls) Notice 2017.
